

### Work safety, work healthcare

### DUE diligence audit (DDA) studies

The term "due diligence" is an English phrase, which means "required care". The EHS area must be part of the "due diligence", when reviewing a company and during this process by investor mandate, professionals look into the company's contracts, permits, registers, they review the applied technology in detail and with special attention they review the environment safety, fire-safety, ADR-RID, background of processing an Environmental Safety Product Fee, in line with upkeeping criteria.

The EHS area "due diligence" is required because the investor firm, must be reassured the information given to them is valid and correct. Unfortunately, an aspect which goes out of scope can cause serious problems later to the organization (e.g.: functioning without an environment safety permit OR not identified / not reviewed assessments, maintenance, etc.)

### Compliance Audit (CA) - adequacy audit Work Safety, Fire-Safety, Environment Safety, ADR-RID, Environment Safety Product Fee

The audit is performed in accordance with a complex audit plan in line with authority review scripts, review points and our own, as well as in a multinational environment, also in the KKV sector and with almost 10 years of experience gained in the public sector, aligned with the practical experience and also the record of questions. We sample the lawful suitability of work, fire, environment safety, ADR-RID, environmental safety product fee with supervising the procedures and functions by visiting sites, surveying, interviewing and by assessing the validity of the documents prepared plus the employer internal rules. The audit report details and evaluates the samples, interviews, the completion of duties as per the documentation and the recorded mismatches, also the comments, suggestions and in a summary chapter, it details the experiences.




